Investment Objective

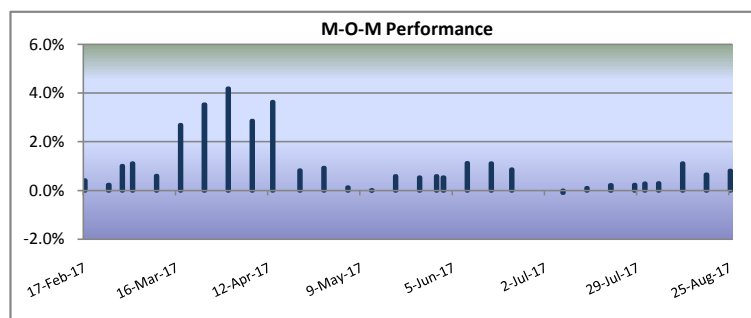
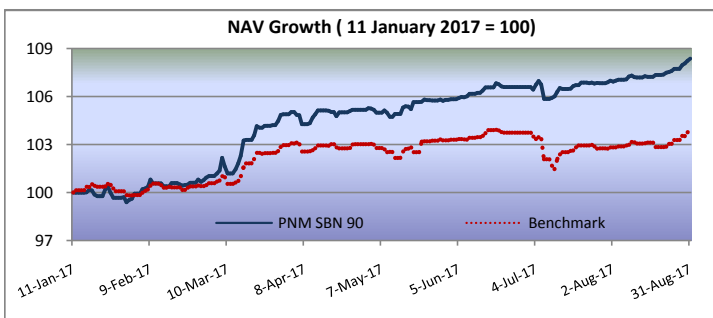
The fund's objective is to achieve optimum long term asset growth through investment in bonds and money market instruments. The fund is actively managed.
